Scenario C: Technical Debt and Slow Load Times

Diagnosis: As a blog grows, the addition of numerous plugins and unoptimized images leads to performance degradation.**Solution:** Perform a **Technical Stack Audit**. Replace heavy plugins with custom code where possible, implement WebP image formats, and use a Content Delivery Network (CDN) like Cloudflare to serve assets from the edge.

8. Legal and Ethical Considerations for Blog, Inc.

A professional blog must operate within legal frameworks. This is not just for compliance but for building long-term trust with the audience. Key areas include:

- **FTC Disclosures:** Clearly stating affiliate relationships and sponsored partnerships.
